### ONLINE Q&A FORUM

- \* Sharing research findings,

- Building a network with other colleagues in the same area of research.

- 1 The discussion will be held through online Q&A Forum *Confgate*.
- 2 Q&A Forum **will be held for 2 hours**.
- 3 In the Q&A Forum, all presenters are **given 1 hour** to ask a question or provide feedback to **3-5 another presenter** (free to choose videos).
- 4 Presenters who are given feedback and questions have the opportunity to provide answers for **the next 1 hour**.
- 5 Giving feedback and questions **must be documented** (screenshots, photos or other forms) and sent through the form <https://unimma.link/Presenter2ndBIS>.

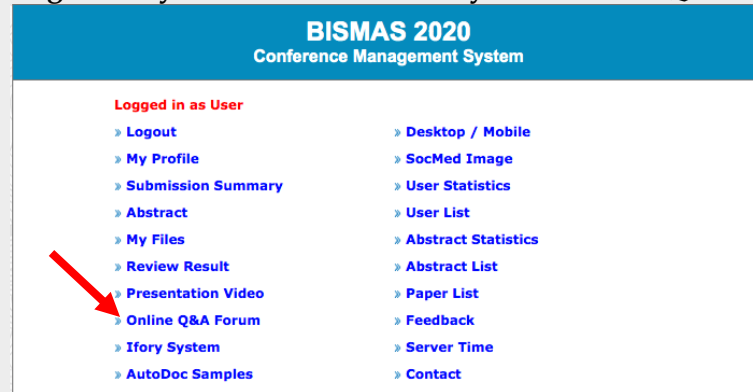

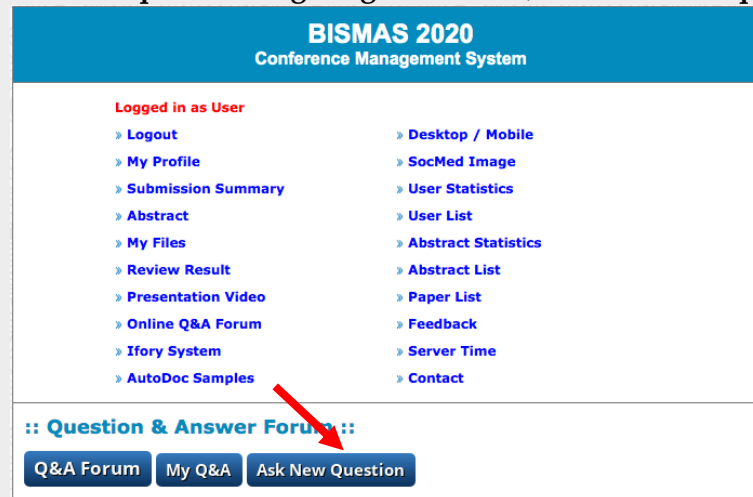


## USER MANUAL ONLINE Q&A FORUM (ASK NEW QUESTION)

2. To ask a question or giving a feedback, click ask new question (*Untuk mengajukan pertanyaan atau feedback, klik ask new question*)




